Last Meeting Follow-up

1. Meeting minutes from the last meeting were read and accepted with no corrections.
2. The Treasury report was accepted and noted for record.
 - a. Beginning and ending balances are not matching but the monthlies and bank statements do.
 - b. Nicole is looking into ways to organize better.
 - c. Pop up barrels were ordered and so were all the office supplies for the year.

Notes

- 1. Rule discussions and changes. Everything passed with everyone in favor.
 - a. Under #5 new rule that the same horse can not be ridden by more than three riders per day.
 - b. Change that the gymkhana tie will be broken by the 50 yard dash and not the figure 8.
 - c. Add that the performance ties will be broken by the scores of equitation.
 - d. Change the wording in #7 to You must show in your division or open for 3 shows to be eligible for year end awards.
 - i. There was conversation around what it would look like if we required 3 shows for year end awards eligibility. It was brought up that weather can knock out a day. But then what about counting the silver show as a pointed show if that were to happen.
 - e. Add that the horse needs to leave the fairgrounds if proper coggins, rabies or health certificate is not provided.
 - f. We talked about really enforcing the 2 minute gate call. Even if they are there trying to work through it. They have their time and then we have to move on.
 - g. Removing meetings from worker hour options. We would rather have them attend an event where they are doing something productive.
 - h. Take out that handlers have to wear a shirt with a sleeve.
- 2. Points and worker hours will be combined this year. There was too much confusion and members started to really overwhelm board members with trying to get information. After each show weekend they will be handed to Carol to go on the pdf. That will be posted on the website.
- 3. Show Dates
 - a. Performance 5/16, 6/14, 7/11, 8/22, Silver Show 9/12
 - i. It was proposed in addition to Mini Halter we add In-hand Mini Jumping and Mini horse obstacle classes to the club show bills, at the silver show last year it brought in some new entries and the members/spectators loved it. It could help grow our performance days if we offer it more than once a year, all were in favor

- c. NBHA weekend 9/19-20 would like more participation from board and members to help run this weekend. It is kinda like a fundraiser for the club. Members can ride with the NBHA non-member fee waived.

7. It was suggested that we offer day end awards for our club shows to try to spark excitement and attendance. If we were to provide a prize for \$8 just for high point winners we would spend \$136 a weekend and about \$550 for all 4 weekends. Performance had 1 show last year that made a profit. It takes a lot of energy to obtain and organize day end awards, board members have a lot already on their plate. It was felt that it was not a good time to try to add this yet. We will add day end awards to the Night Show and will continue to do it for the Halloween show.

8. Ribbons it was suggested we order all of our ribbons for the year now while we can use the 10%. We are in a position to do it and it would save \$400.

9. Speakers

10. Silver Show

- b. Silver Show sponsors should start being filled the first show weekend right in the office.

- f. Teresa will do the coleslaw again with the donated item Lacey can hopefully get
- g. Beginning of March Lacey should have everything ready to roll as far as paperwork and sign ups and extras like the facepainting
